**Conditions of Contract:**

1. Cakes kits must be paid in advance or prior to the start of the workshop via cash or check made payable to "Cakes Unlimited, Inc.". Each member **MUST** have a paid cake kit or they cannot participate in the workshop – no exceptions.
2. Each Brownie Girl Scout cake kit costs \$12.99 (and is tax exempt). It includes one (1) 5" cake layer, one (1) 6.5 oz. pre-filled buttercream icing pastry bag, one (1) 4.5



- oz. colored pre-filled buttercream icing pastry bag, cake comb, 6" cake box and board and a star decorating tip.
3. For the chocolate decorations, there is an additional flat fee of \$1 per girl.
  4. Additional filling(s) may be purchased for \$1 for each filling per girl.
  5. A \$35 fee will be assessed to the customer (named above) for all returned checks.
  6. The customer (named above) accepts all responsibility (including the conduct) of all persons in attendance and for any damages or other issues associated with them. Cakes Unlimited, Inc. at no time accepts responsibility for the attendees – if a minor is in attendance, then an adult must accompany them at all times.
  7. Cakes Unlimited, Inc. will not accept responsibility for the damage, or loss of any property pertaining to this event.
  8. Cakes Unlimited, Inc. is not responsible for reasons beyond its control including, but not limited to, acts of God, labor disputes, commodities or supplies, acts of war, etc. which prevent the company from performing its obligations. If such non-performance occurs, the customer (named-above) agrees to release Cakes Unlimited from this agreement without further liability.
  9. Cakes Unlimited, Inc. will perform the proposed services in a professional manner conforming to generally accepted industry standards with full compliance with applicable laws. Your sole remedy will be either to have Cakes Unlimited, Inc. correct any deficiencies in the services, or to terminate this agreement without any recovery of the fees paid for the deficient services.
  10. In no event will Cakes Unlimited, Inc. be liable for any indirect, consequential or incidental damages arising out of this agreement. In no event will Cakes Unlimited, Inc.'s liability under this agreement exceed the amounts received from you by Cakes Unlimited, Inc.
  11. In the event any provision of this contract is deemed to be void, invalid, or unenforceable, that provision shall be severed from the remainder of this contract so as not to cause the invalidity or unenforceability of the remainder of this contract. All remaining provisions of this contract shall then continue in full force and effect. If any provision shall be deemed invalid due to its scope or breadth, such provision shall be deemed valid to the extent of the scope and breadth permitted by law.
  12. New Jersey law will govern this contract.
